- How will DBE participation be scored?
 - DBE participation is not scored it based on the proposer meeting the goal. Not meeting the goal will be considered nonresponsive unless there is a clear written demonstration on the submitter's Good Faith Effort.
- If a good faith effort is made to secure DBE partnership, but 22% is not achieved, how is this scored?
 - Once again DBE participation is not scored but if the proposer is unable to meet the goal they must provide their written Good Faith Effort demonstrating why they were unable the meet the goal – Good Faith Efforts are reviewed and approved/denied by KDOT.
- Can you confirm the date questions are due? The question deadline is referred to as Friday, August 21st in the RFP?
 - Questions are due Monday Aug 21 – responses posted Friday Aug 25
- Can you confirm that only 2 pages for resumes (total) are allowed, and not simply a maximum of 2-pages for each staff resume?
 - 2 pages max per staff resume
- If included, how will the interview be scored in the evaluation process?
 - Interviews are scored using the same criteria as the Evaluation process.
- Will the interviews be virtual?
