The original bid document issued on October 2, 2025, is revised as follows:

CHANGE: Page 3 of the bid document to read:

CONTRACT PERIOD: January 1, 2026 to December 31, 2027 (with option to renew for three additional one-year periods and subject to adjustment based on award date).

Labor Rates - Appendix A (Tab 1)

Q. Will we be able to add line items to the labor rates to include lift rental and subcontractor pricing as percentages of markup.

A. Appendix A – Labor Rates tab is revised by adding lift rental and subcontractor pricing.

Category A Surveillance Cameras (Appendix A – Tab 3 Specifications)

Q. Upon review I noticed that the Camera Pole section allows no exceptions for hole in poles. I don't quite follow this as poles always have holes to allow the CAT6 cable to route through the inside of the pole from the ground up to the camera.

A. Category A (Appendix A Excel) is changed to read:

"All camera brackets on the pole at location, shall be mounted, preferably, using a metal strap band mounting bracket so that no drilling into the pole is required to hold the camera. Written authorization by the property owner (i.e., agency or utility company) must be obtained prior to any added holes the Contractor deems necessary for installation."

Category B Portable Trailer Mounted Surveillance unit (Appendix A – Tab 3 Specifications)

Q. We offer multiple options and configurations for how to provide a Portable Trailer Mounted Surveillance unit. Do we need to provide one exactly as described, or can we be more open to the needs of the Participant?

A. If quoting an alternate, bidders must provide alternate description for each criteria that meets the stated functionality of a portable solar-powered trailer-mount, or state "no bid" in column D Exceptions/Alternates.

Category C – Building Access Control (Appendix A – Tab 3 Specifications)

Q. This section states "Building access control shall be compatible with Genetec access control software.", but we offer other brands that are not compatible. Is this intentionally restricting things to only Genetec systems?

A. The section is changed to read "Building access control shall be compatible with Genetec access control software". If a manufacturer/brand is offered that is not compatible with Genetec, bidders must state "non-compatible".

Bidders may list any alternates (example below) in response on Appendix A, Tab 2 – Product Offerings:

CATEGORY C:	CONTROLLED BUILDING ACCESS SYSTEMS, PANIC ALARMS (UNDER DESK, WEARABLE)
State manufacturer	State catalog/date of price sheet and *not Genetec compatible*.
