Request for Qualifications

Assistance to Local Health and Community Organizations on Billing Public and Private Insurers for Health-Related Services

The Mid-America Regional Council (MARC) is the association of local governments and metropolitan planning organization serving the 9-county bi-state Kansas City metro area. MARC supports a regional Community Health Worker Collaborative, and has worked with local and state governments, community and health organizations and others to build a strong CHW workforce in the metro area and the states of Missouri and Kansas.

One of the barriers to further expanding the use of Community Health Workers by health and community-based organizations is the ability for those employers of CHWs to bill for, and be reimbursed for CHW services as part of a health care team. In 2022, MARC supported the preparation of a toolkit on how public and nonprofit organizations and health care organizations could bill for such services provided by Community Health Workers. The toolkit identifies categories of services that can be provided by unlicensed providers within a clinical care team and billed for by the rendering provider. The toolkit was prepared by Erika Saleski, Principal, ES Advisors, LLC and Tim McNeill, co-founder, Freedmen's Health. The toolkit is available on the MARC website at CHW Toolkit | MARC

MARC is seeking a Contractor to assist local agencies to adjust their operations and billing processes in order to seek reimbursement from Medicare, state Medicaid or private insurance providers according to the categories of services identified in the toolkit. MARC is looking for a Contractor who is knowledgeable about health insurance billing and is available to assist local agencies to review their processes and to make specific recommendations on changes in their processes or steps needed to enable them to bill for the categories of services (identified in the toolkit) provided by a CHW. MARC expects to support up to six organizations in this work including both clinical providers and one community-based organizations (CBO). If the CBO is not currently set up to bill health insurance, Contractor may also need to assist CBO in advising on the contents for an agreement with clinical providers as well as reviewing and recommending updates to processes and workflows to meet the service and billing requirements.

Review Process

MARC staff, CHW Collaborative leadership and Erika Saleski (MARC's consultant) will review qualifications based on the following criteria:

- Experience and expertise with similar work
- Knowledge of public and private insurance billing procedures and practices
- Capacity and availability to provide technical assistance to up to 6 organizations by December 31, 2023 (Possible grant funds could enable additional services in 2024).
- Ability to assist MARC and the CHW Collaborative to outline ongoing work to support
 the full implementation of the toolkit, and to make any changes or additions to the
 toolkit that could make it a more useful resource.

Consultants interested in assisting MARC and the CHW Collaborative with the above work should submit the following information:

- 2. Description of your capabilities and experience in supporting the design of agency operations and billing practices for health insurance reimbursement of health care team expenses. Identify personnel to be assigned to the project and their qualifications
- 3. Your approach to working with MARC and your hourly fee
- 4. Description of up to three similar projects with approach used and results achieved, and examples of design work.
- 5. Three references, including name, organization, phone, email address
