## ISSUE:

VOTE: Approve FTA Section 5310 Funding Recommendations (funds not yet programmed)

## **BACKGROUND:**

A call for projects and project selection process for FTA Section 5310 funds program recipients occurred over the summer of 2022. During the September 7, 2022 meeting, the Mobility Advisory Committee arrived at funding recommendations for a total of \$1,683,816 in funds.

Subsequent to the September MAC meeting, calculations for funds to be programmed were adjusted, yielding an additional amount to be programmed of \$187,094. Two options for disposition of these funds are as follow:

- a) Provide additional funding to agencies already awarded funds in September.
- b) Provide funding of two additional agencies with a partial award.
  - a. Center for Developmentally Disabled
  - b. TNC Community

A table describing these two options is attached in the following page.

At the upcoming MAC meeting, MARC staff will brief the committee on this opportunity and will seek recommendations on award of funds to agency recipients.
