

How ILOs Submit a Terrorism-related Tip

KCRFC supports the DHS See Something, Say Something program to encourage reporting of suspicious activity. Describe specifically what was observed, including:

- **Who** or **what** was seen;
- **When** it was seen;
- **Where** it occurred; and
- **Why** it is suspicious.

Terrorism related suspicious activity that is observed online or in person that is an imminent threat should be reported to 911. Terrorism-related suspicious activity that is a non-emergency should be reported using the SafeNation SAR app (Apple or Android), or by using the links below:

Intelligence Liaison Officer (ILO) Program

The Kansas City Regional Fusion Center (KCRFC) brings local, state, and federal law enforcement officials together with public and private organizations to detect, deter, and respond to terrorist threats in the greater Kansas City community.

The KCRFC collects information from a variety of sources. This data is evaluated and analyzed to identify potential trends or patterns of terrorist or criminal operations within the region.

Program Goal

The Intelligence Liaison Officer (ILO) program creates connections with partners with the end goal of mitigating threats to life and property. Timely and accurate intelligence reporting and analysis can deter or prevent terrorist acts from occurring. Early recognition and detection of indicators are keys as collection of information is a major element of the intelligence cycle.

What is an ILO?

An ILO is an individual in law enforcement, military, corrections, Fire/EMS, and public or private sector who functions as a principal point of contact in matters dealing with the recognition and detection of potential terrorist activity. ILOs are vetted and trained to recognize, receive, and report pertinent information to the KCRFC.

Additionally, ILOs are points of contact to receive and share information generated by the KCRFC or its federal, state, local, tribal, territorial, or private sector partners.

ILO Roles and Responsibilities

ILOs will be expected to:

- Serve as the KCRFC's point of contact for the agency/organization.
- Receive leads from within the agency/organization regarding suspicious activity that potentially has a terrorism or major criminal activity nexus and report that information to the KCRFC.
- Review all information received from the KCRFC that may impact the agency/organization.

ILO Requirements

Law Enforcement (LE): must be employed by a federal, state, local, tribal, or territorial LE agency, the United States Department of Homeland Security, or by the United States Military in an LE or LE support position.

- Non-Law Enforcement: must be employed by or actively working/advising (i.e., not consulting only) an agency/organization that is within the DHS 16 Critical Infrastructure Sectors.
- Must work within the KCRFC area of responsibility (AOR);
- Must have a valid "need-to-know" or "right-to-know" Sensitive but Unclassified (SBU) Information.
- Must hold a position that has access to or would be enhanced by information regarding potential terrorist and/or major criminal activities.
- Must have supervisory approval to attend the ILO Training Program and to fulfill the ILO responsibilities.
