3/24/2025 Community Health Worker grant terminated by CDC through KDHE. The grant began in January 2023, and with a recent grant amendment that had increased to \$789,248 with the funds available through mid-July. We had spent \$648,000 of the grant. Still some remaining costs that we hope to recoup.

# Safety and security



- **RHSCC** met and decided to continue with basic functions [realizing they are at risk but could be covered by reserved local contributions] for **one month.**
- **Basic functions** include: MARC staff, ongoing programmatic support, support of health and medical analyst position at Olathe FD and two outreach coordinators that work out of the Kansas City Police Department Fusion Center, and monthly subscription costs for ongoing services e.g. radios and mi-fi's, secured internet.
- Estimated risk for that one month is \$66,000.
- Pause on planned Cybersecurity exercise and training.
- Reevaluate at their next meeting.



# **Head Start**



- Since 1974, provides comprehensive health, nutrition and education services to children in poverty with the goal of helping them be kindergarten ready.
- Based on four major components of education, health, parent involvement and social services.
- Must be below poverty level to be eligible, family of four making less than \$32, 150.
- Annually: 800,000 children, 275,000 staff and 1600 grant recipients

# **Older Americans Act**



- Realignment under HHS splitting OAA program between two agencies
- Eliminating funding for safety programs including Chronic Disease Management, Ombudsman and Adult Protective Services programs
- Continuing resolution included flat funding which means a reduction in service levels due to increasing demand, increasing costs and new administrative requirements
- Delay in reimbursements of federal to states
- Uncertainty about federal budget in September
