MINUTES

Welcome and Introductions (Co-Chairs)

Welcome and introductions made by Missouri Co-Chair, Michael Park. See attendance for those present.

Highway Committee 9/25/24 meeting summary (Co-Chairs)

Michael Park opened for a motion to approve the 9/25/24 Meeting Summary. Michael Spickelmier made a motion, and Sherri McIntyre seconded the motion to approve the 9/25/24 Meeting Summary. The motion passed unanimously.

Reconnecting Communities - Reconnect Westside (Nicolas Bosonetto, KCMO)

Nicolas discussed the history of federal transportation investment in Kansas City's Westside neighborhood and how the negative impacts of those projects created the need for this study. He detailed the impacts of elevated urban expressways and connected those issues to the goals of the study. Nicolas then shared more details about the Reconnect the Westside scope, schedule and consultant team.

Michael Park opened the floor for any questions. Bobby Evans asked if the Reconnect Westside project team planned to meet with the Beyond the Loop project team to discuss lessons learned and share and

relevant information. Nicolas responded that this coordination is in the works. Matt park asked if there were examples of similar projects resulting in highway removal. Nicolas deferred to Bobby Evans who discussed several similar projects and their resulting infrastructure changes. Ron McLinden asked a question about contributing factors to noise pollution. Several participants discussed the issues surrounding reducing the speed of vehicles on the interstates in the urban core.

MARC Safe Streets and Roads for All (SS4A) Grant (Alicia Hunter, MARC)

Alicia started with an overview of the SS4A grant and the intent of the program. She then detailed the scope of work, procurement schedule, and consultant selection process. Alicia finished with the next steps that the selected consultant, Toole Design, will complete: Coordination Meetings, Public Engagement and PM1 Safety Targets and Methodology.

Micheal Park opened the floor for any questions. Bill Noll asked about some details about the scope of the project. Alicia responded that this project will not identify specific projects for the region as a whole.

MARC Performance Measures (Bobby Evans, MARC)

Bobby began by briefly discussing the history of federal requirements for federal performance measures. He detailed how performance measures are factored into decision making and the 15 performance measures.

Bobby then provided an update on the progress for data collection, data processing, and target setting for each of the performance measures. Bobby also discussed some of the changes in methodology and the associated considerations taken into account for those changes.

Matt then opened the floor up for questions. Jeff Bryan asked about data collection methodology with respect to comparisons over time. Bobby responded that comparisons over time were a top consideration in data collection and processing. Nic Bosonetto asked about doing volume counts on bike facilities to supplement the existing performance measure. The group then discussed the difficulties associated with counting pedestrian and bicycle volumes. Matt Park mentioned the limitations of journey to work data and the associated need for bicycle counts. Bill Noll asked about mapping of the regional trails. Martin mentioned the regional bikeways and trails map produced by MARC. Ron McLinden asked about different kinds of bicycle facilities that encourage more people to ride bikes. Bobby responded that historical data shows a correlation between the implementation of bike infrastructure and the growth of bike ridership.

Jeff Bryan asked about the relationship between tree canopy coverage and heat island effect. Bobby responded that the tree canopy measure does not cover temperature. Matt then suggested that the performance measures be tied to VMT to help make comparisons over time and between jurisdictions easier. Bobby responded that the safety performance measure does factor in VMT>

Roundtable Updates

Cy mentioned the Connected KC 2050 online engagement tool. Ron McLinden asked about future funding amounts with the incoming Trump administration. Ron Achelpohl suggested that the funding amounts likely will not change but the programmatic focus could of the funding will.

The meeting adjourned at 2:55 p.m.


Brief History of Westside

- Growth and immigration in early 1900's
- Highway Construction 1950s-1970s
- Highways were typically built through minority/low-income neighborhoods



Impacts of Highway

- Displacement of residents
- Pollution
 - Air Pollution
 - Noise Pollution
 - Light Pollution
- Negatively affects health of residents
- Bisects Westside
- Limits access and mobility
- Visually unattractive
- Separates Westside from the city






I-35 Needs

Current Viaduct is 70+ years old

Decision on major reinvestment in corridor will soon be necessary









Regional Mobility Trends

USDOT Reconnecting Communities Pilot Program

- Focused on mitigating harm of past infrastructure investments that divided and displaced communities
- Authorized by Infrastructure Investment and Jobs Act (IIJA) and Inflation Reduction Act (IRA)
- Authorizes Capital Construction and Community Planning Grants (this Award)


Transportation and Infrastructure-Related Barriers

- I-35, I-670 and connection to Central Business District
- Beardsley Road and connection to the Westside Bluff
- Internal Barriers (arterial streets, railroads, topography, water)




Reconnecting Communities Grant

- \$1 Million Grant March 2023
- One of 45 communities to receive the grant
- Plan for the future of the aging I-35 viaduct, which has passed its projected life span.
- Design connections between the Westside community and the Central Business District.
- Create design solutions for Beardsley Road to connect the Westside with economic and residential development in the West Bottoms. Currently, Beardsley Road is a dark and hazardous two-lane road.














Federal Performance Measures - FHWA


- (PM 1) Performance Measure 1: Safety

 - Motorized & Non Motorized





Federal Performance Measures - FHWA


- PM 2 Infrastructure Condition Pavement & Bridge
 - Good vs Poor Condition
 - National Highway System
 - Interstate vs Non-Interstate System





Federal Performance Measures - FHWA

- PM 3 System Performance
 - level of travel time reliability (LOTTR)
 - Truck Travel Time Reliability (TTTR)





Federal Performance Measures – NEW*

- Greenhouse Gas Emissions
 - % change in tailpipe emissions vs 2022
 - Fuel consumed and VMT
 - Target setting is much more complicated
 - * Pause on requirement for a federal lawsuit



Federal Performance Measures - FTA

- Transit Asset Management (TAM)
 - % of revenue vehicles exceeding ULB
 - % of non-revenue service vehicles exceeding ULB
 - % of facilities rated under 3.0 on the TERM scale
 - % of track segments (by mode) that have performance restrictions




Federal Performance Measures – FTA, cont'd

- Public Transportation Agency Safety Plan (PTASP)
 - Number of fatalities
 - Fatalities rate per VMT by mode
 - Number of reportable injuries
 - Reportable injuries per VMT by mode
 - Number of safety events
 - Number of safety events per VMT by mode
 - Mean distance between major mechanical failures by mode

Shared Use Paths: **900 miles**


