1) Introductions and Approval of Meeting Summary – Co-chairs

Mike Duffy, MO Co-chair, called the meeting to order and started introductions. The meeting summary from April was provided for the committee's approval, no questions or comments were made. Maitland Mehlhaff made a motion to approve the April 2025 Minutes, and Chris Gutierrez seconded that motion. The motion passed unanimously.

2) Final Report – Regional Freight Study – CDM Smith

Davonna Moore-Edeh, Project Manager, presented the final report for Connected Freight KC 2050, including the findings, recommendations, and future steps for the plan. Discussion followed on incorporating livability into future freight work, system resilience, and updates to Freight Activity Centers in future work. Mike Duffy opened the freight study up for a vote to recommend the study's approval by the Total Transportation Policy Committee; Chris Gutierrez motioned for approval, and Maitland Mehlhaff seconded that motion, the motion passed unanimously.

3) Introduction to Sustainable Places Policy Committee – Cy Splichal and Beth Dawson, MARC

Cy Splichal and Beth Dawson, MARC, presented an introduction to the Sustainable Places Policy Committee and Planning Sustainable Places Program. The regional freight study encourages future freight work to align

with the SPPC and land-use planning at MARC. Discussion followed on how to better incorporate freight considerations into work on centers and corridors.

4) MARC Committee Structure Update – Martin Rivarola

Martin Rivarola, MARC, gave a brief report on future work that MARC staff are coordinating to simplify the transportation committee structure, including Good Movement Committee. He explained that more information would be presented at future meetings, including how to continue representing freight priorities in MARC's planning processes.

Mike Duffy opened the floor to updates from any committee member.
